This Waiver and Release covers all 2024 Santa Clara Bass Busters club tournaments and events. All members must read, understand, agree and sign this waiver prior to participating in any Santa Clara Bass Busters tournament or event.

In consideration of the acceptance of my entry in any, and all 2024 Santa Clara Bass Busters tournaments / events, I hereby waive and release any and all rights to claim of damages which may occur during my participation in 2024 Santa Clara Bass Busters tournaments / events. By signing this waiver and release I am stating I have read and understand all rules and regulations of Santa Clara Bass Busters tournaments / events / bylaws. Furthermore, if I am involved in an accident while participating in a Santa Clara Bass Busters tournament / event I hereby release the Santa Clara Bass Busters from responsibility or liability of any said damages to the other parties' occupants, vehicle and / or boat and equipment, this will also include lake property i.e.; boat docks, lake marina's etc...

In the event of an accident while participating in a Santa Clara Bass Busters tournament / event in bill be my sole responsibility (Unless unable to do so) to contact my insurance company and the local law enforcement (if necessary) and report all accidents. I also understand if any damages occur during said Santa Clara Bass Busters tournaments / events I release Santa Clara Bass Busters and its insurance company from any responsibility and / or liability of said damages. I also understand it's my sole responsibility to maintain and possess a current and up to date policy of my insurance coverage during 2024 Santa Clara Bass Busters tournaments / events. I understand my proof of insurance must carry a minimum of \$300,000 in personal liability in order to be eligible to participate in a Santa Clara Bass Busters tournament / event. At any time, the Santa Clara Bass Busters and / or its board members may request to inspect your insurance policy to confirm your policy it up to date and current. If said member does not produce a current up to date policy with the required minimum (\$300,000) personal liability, he / she will not be allowed to participate in the tournaments / events until the insurance policy meets the requirements of Santa Clara Bass Busters. At any time, the Santa Clara Bass Busters and its board members have the right to revoke membership if all rules / regulations are not followed by said member.

In the event of a non-club sponsored event (i.e. TurkeyShoot or pre-fish) members will assume full responsibility for themselves, equipment and other property or persons in the event of a loss.
